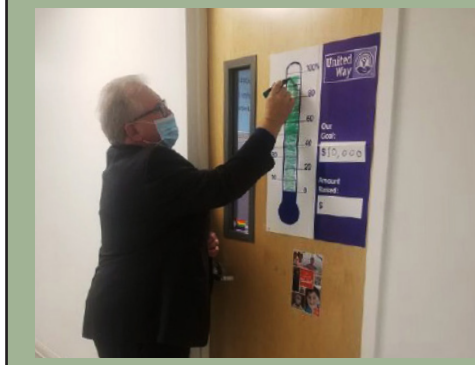
## NAACP Honors

## A.T. Still University (MOSDOH) Partnership

Veterans Smile - Several special dental screening days for veterans were held during 2021 at the St. Louis Dental Center, a partnership of the A.T. Still University's Missouri School of Dentistry & Oral Health and Affinia Healthcare. Many veterans have no insurance or access to care, and the Veterans Administration only offers limited dental services. This is the fifth year in which a special screening day for veterans has been offered at the St. Louis Dental Center. Since the program began, more than 770 veterans in all branches of service and every war have received screenings. Nearly 400 veterans are currently receiving on-going dental treatment. We are honored to be able to serve our veterans during these special events, and every day!



## United Way Employee Giving Campaign

Affinia Healthcare participated in the 2021 United Way Employee Giving Campaign, exceeding our \$10,000 campaign goal. The campaign ran from September 25 through November 25. Many of the resources provided by United Way help address negative social determinants of health that impact our patients' lives, such as early childhood education, financial literacy resources, and health and social services. Affinia Healthcare is a proud United Way member.

# Partners



## Services to Refugees

Since September 2021, Affinia Healthcare has partnered with the International Institute to provide primary medical, dental, behavioral, and preventive health services to displaced Afghan allies receiving resettlement assistance. The collaboration extends to the St. Louis City Department of Health for the provision of required health services, such as screening and treatment for TB, and COVID-19 vaccinations.



## City Partnership to Address TB

Affinia Healthcare partnered with the City of St. Louis on several initiatives including a new Tuberculosis (TB) Services Clinic. TB services are offered by the City of St. Louis Department of Health in renovated space at our 2220 Lemp Avenue location. The City of St. Louis Department of Health staff provides direct TB services, and patients also benefit from access to related services offered by Affinia Healthcare, such as diagnostic X-ray services, Urgent Care, and support services such as assistance with Medicaid applications.



## Public Safety is a Public Health Issue

In line with its comprehensive approach to public health, Affinia Healthcare partnered with the St. Louis Metropolitan, Pagedale, and the Normandy police departments to provide gun locks to area residents. This is in response to numerous accidental gun deaths in the areas served by Affinia Healthcare. Affinia Healthcare reached out to area law enforcement agencies to distribute the safety devices to help curb accidental gun deaths. The gun locks are distributed free of charge to our patients and others in the community who request them.



## Serving Unhoused Individuals

Needs don't go away because someone is without housing. Affinia Healthcare meets with unhoused individuals to schedule medical and behavioral health appointments for the unhoused community at temporary shelters throughout the city. Services include patient navigation, case management, referral coordination and substance use disorder treatment provided in collaboration with St. Patrick Center, Bridgeway Healthcare, and the Salvation Army's Harbor Light Center.

# Quality Improvement

Through committed and inspired leadership, clinicians, and dedicated staff, the following key measures exemplify how we are moving the quality-of-care needle.

## Child Weight Screening/ BMI percentile + nutrition & physical activity counseling

Childhood obesity is an epidemic in the United States. Screening for youth body mass index and nutritional counseling can help youth develop healthy habits that will help them stay in good shape as they transition into adulthood.

## Hepatitis C Screening for Baby Boomers

Getting tested for hepatitis C is important, because treatments can cure most people with hepatitis C in 8 to 12 weeks.

## Tobacco Use: Screening & Cessation

Studies show the risk of heart attack begins to drop two weeks after you stop smoking. The sooner you quit, the sooner your body begins to heal. Patients who stop smoking are more likely to live a longer and better quality of life.

## Diabetes: Retinal Eye Exams

Vision problems may be an early symptom of diabetes. Retinal exams can help patients prevent this serious condition.

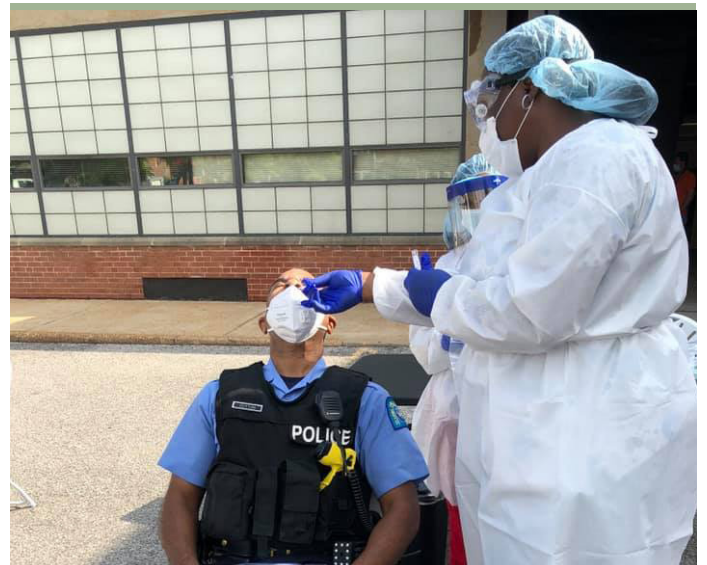
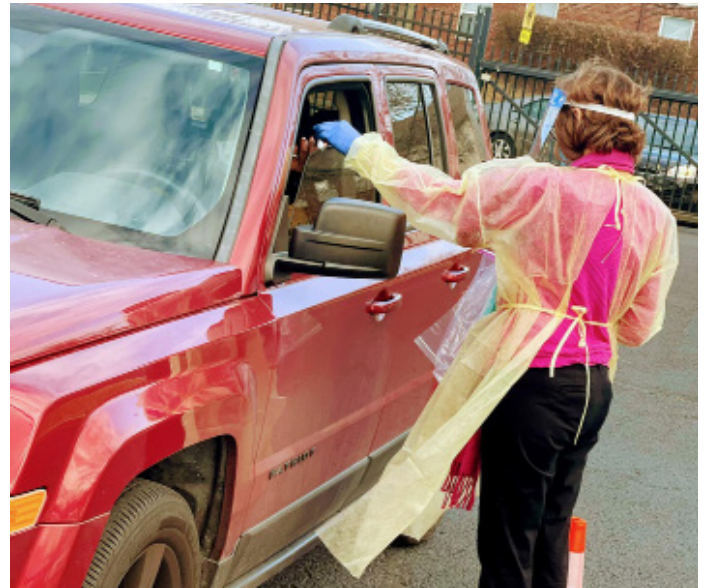
Among other challenges brought on by the COVID-19 pandemic, a report cited significant increases in self-reports of depression, anxiety and emergency room visits for mental health challenges. Our Behavioral Health practice also saw an increase in mental health screenings for adolescents was also cited.

# Continuing the Fight Against COVID-19

As 2020 wrapped up, the Federal Drug Administration (FDA) granted emergency use authorization for the first **COVID-19 vaccine**, providing healthcare providers another tool to continue the fight against the virus. Shortly thereafter, Affinia Healthcare received approval from the State of Missouri to administer the COVID-19 vaccine to our patients, staff, and the community. Application to become a COVID-19 vaccinators was made through the State's ShowMeVax program.

The Affinia Healthcare **Health Outreach and Community Health Teams** hit the streets, setting up in gyms, churches and community centers and other locations throughout the St. Louis metropolitan area to offer COVID-19 vaccines to members of the community, as well as to patients at our health center locations. Some of the locations we were fortunate to serve were outreach events at Tandy Park, the International Institute, James Eagan Center in Florissant, and Beyond Housing in Pine Lawn.

In addition to vaccines, Affinia Healthcare also provided an innovative therapy to help reduce the symptoms of COVID-19, especially in those high-risk patients. The **monoclonal antibody infusion** therapy is prescribed for patients who have mild to moderate symptoms of COVID-19 and an elevated risk of complications. Data from clinical trials showed that high-risk patients treated with monoclonal antibodies had a 70% reduction in relative risk of progression to severe disease or hospitalization compared to patients who did not receive monoclonal antibodies. Affinia Healthcare also extended its reach to treat patients, partnering with the City of St. Louis Department of Health and the Missouri Department of Health and Senior Services to help provide monoclonal antibody infusion therapy for St. Louis City and St. Louis County inmates who have tested positive for COVID-19.



# Addressing Social Determinants of Health

The COVID-19 public health emergency posed new barriers to health care access and worsened many existing disparities. In 2021, with a vaccine now available, Affinia Healthcare incorporated this new strategy to help stem the spread and minimize the negative impact on the community.

Affinia Healthcare has provided over 24,500 COVID-19 tests for under-resourced and vulnerable individuals in the St. Louis region, accounting for approximately 20% of all COVID-19 testing by Missouri's community health centers. Our testing activities have helped support access for those disproportionately impacted by the pandemic. We have served more individuals in the community than ever before by collaborating with organizations to reach a majority Black and Hispanic/Latinx populations, the unhoused, public housing residents, refugees, and the LGBTQA+ community.

## TELEHEALTH

Remote Care has become an excellent venue for expanded access to health care services for our patients. With new technologies available, such as video-supported patient visits and integration of telehealth with electronic medical records, many primary medical and behavioral health visits can be effectively provided in the most convenient manner for patients. Telehealth removes barriers to care by eliminating the need for patients to find transportation to healthcare appointments. Initiated during the pandemic, telehealth remains a viable option for our patients and staff, offering an alternative method of providing healthcare. In addition, through telehealth services, we are able to reach more patients who live in areas of our community who lack sufficient access to primary medical and behavioral health services.



## DISTRIBUTING ESSENTIAL GOODS

Affinia Healthcare distributed diapers, food and essential items at our health centers, public housing, and other community locations to help address the impact of the negative social determinants of health, exacerbated in underserved communities due to the COVID-19 pandemic.



## BLOOD DRIVES

As part of our COVID-19 response and to offer our staff other ways to help the community, Affinia Healthcare partnered with the American Red Cross of St. Louis to conduct a series of blood drives. The blood drives help address the blood reserve shortages caused by the COVID-19 pandemic. This collaborative effort was expanded to include Grace Hill and The Urban League of Metropolitan St. Louis on three different drives.



## INFLUENZA VACCINATIONS

Affinia Healthcare was awarded a contract by the St. Louis City Department of Health to administer the influenza vaccine at community locations, free of charge. The flu vaccine was especially important this year due to the COVID-19 crisis. Prevention activities which help protect communities that are disproportionately impacted by COVID-19 and other health disparities are at the core of our mission.



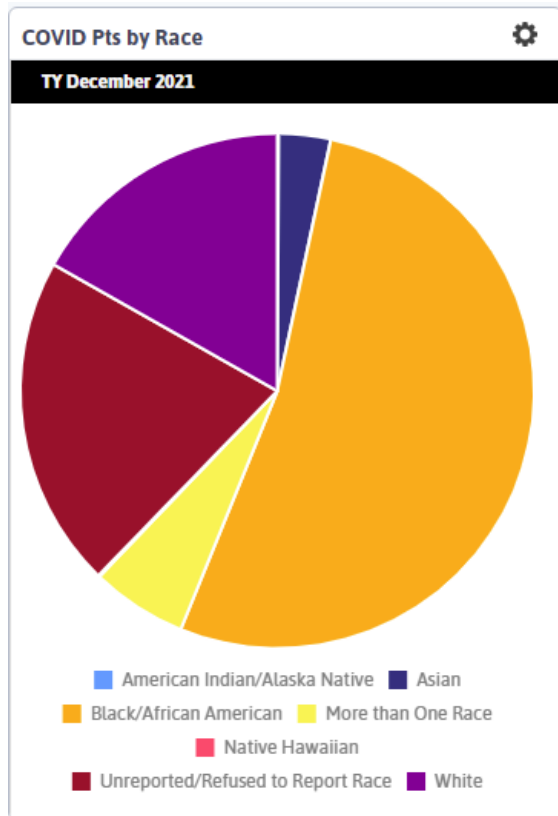

## SAFETY MEASURES

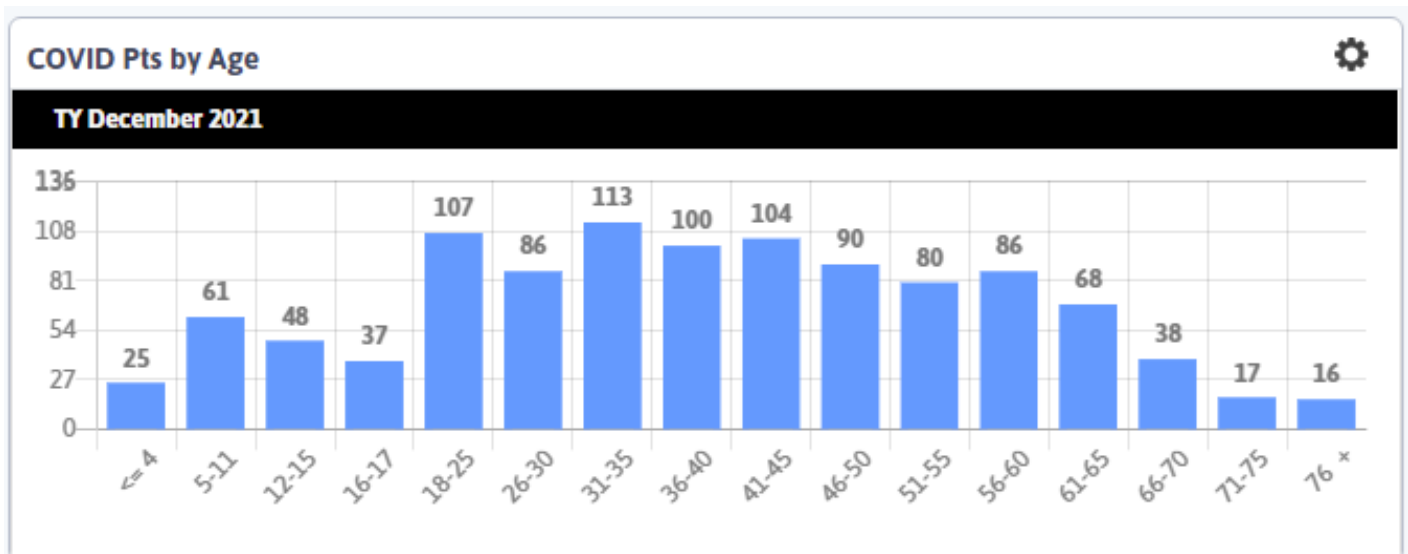
While we transitioned some of our in-person patient visits to telehealth, throughout the pandemic we continued to see patients in our health centers while keeping them and our hard-working staff members safe during the pandemic. We added temporary plexiglass at all workstations where staff routinely interact with patients, and implemented social distancing, sanitation, and temperature check protocols at all of our locations.

# COVID-19 Data

In 2021, of the 14,430 people who came to Affinia Healthcare for their 1st dose of the COVID-19 vaccine, 11,465 chose to be fully vaccinated through our services. This equates to 79 percent of these community members being fully vaccinated at the end of December 2021.

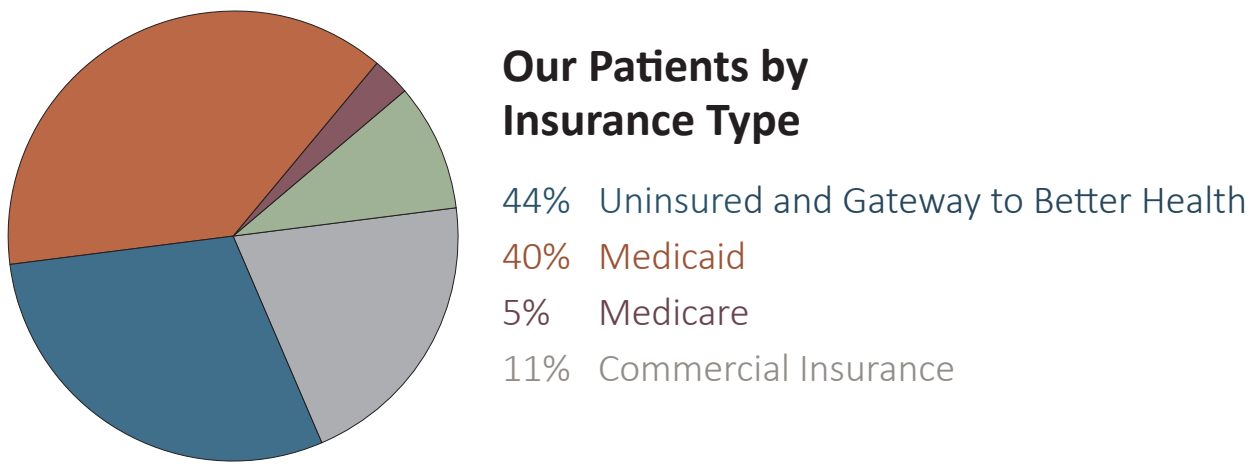
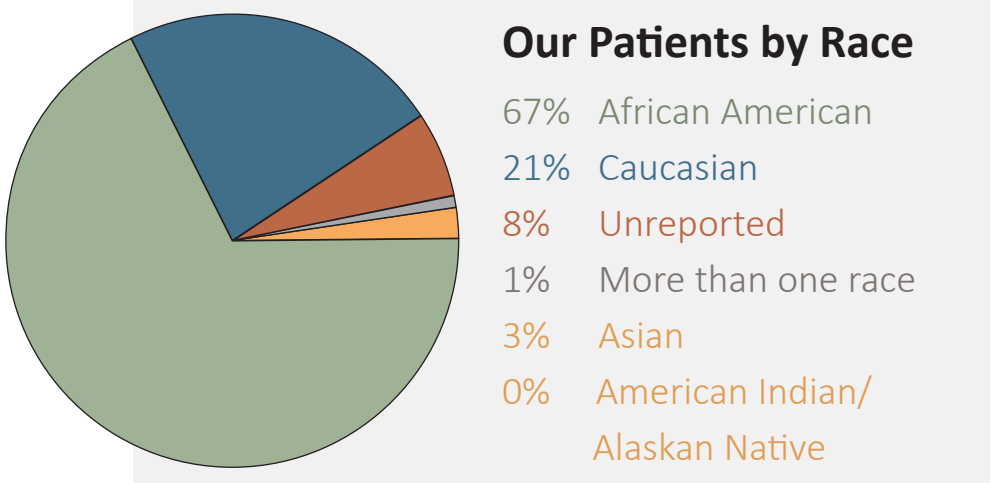
In the face of the COVID-19 pandemic, 36,339 patients received clinical services and an additional 24,500 COVID-19 tests were provided. Affinia Healthcare served 81% of the total volume of patients forecasted before the pandemic.

# Financials

While adjusting to this new normal and working to keep COVID-19 numbers down, Affinia Healthcare maintained a healthy financial position in 2021.

One of the charges for the Affinia Healthcare Board of Directors and senior leadership is to remain cautious stewards over our financial resources. In 2021, the second year of COVID-19, we continued to strategize how to best utilize the significant resources provided to help Affinia Healthcare continue its response to COVID-19 crisis, still provide testing, but move the emphasis of this work to vaccination and prevention.

In 2021, Affinia Healthcare reported an operating income of \$3,865,114, and an operating margin of 7.5 percent on net revenues of \$51,667,484. Patient service revenue, reimbursements from Medicaid, Medicare and commercial insurance, and patient co-pays represented 51 percent of total revenues. Grant revenue increased to 33 percent to offset the cost of care provided to individuals who qualify for the sliding fee and to provide for the cost of COVID-19 testing and other pandemic-related activities. Another 16 percent was received from private grant funders and donors. More than 83 percent of our revenues support direct services to the community through our medical, dental, mental and behavioral health, pharmacy and WIC (Women, Infants, and Children) nutritional services.

The financial health of Affinia Healthcare is strong, with a current ratio that exceeds 4:1, and cash on hand of about 107 days of average operating expenses at December 31, 2021.

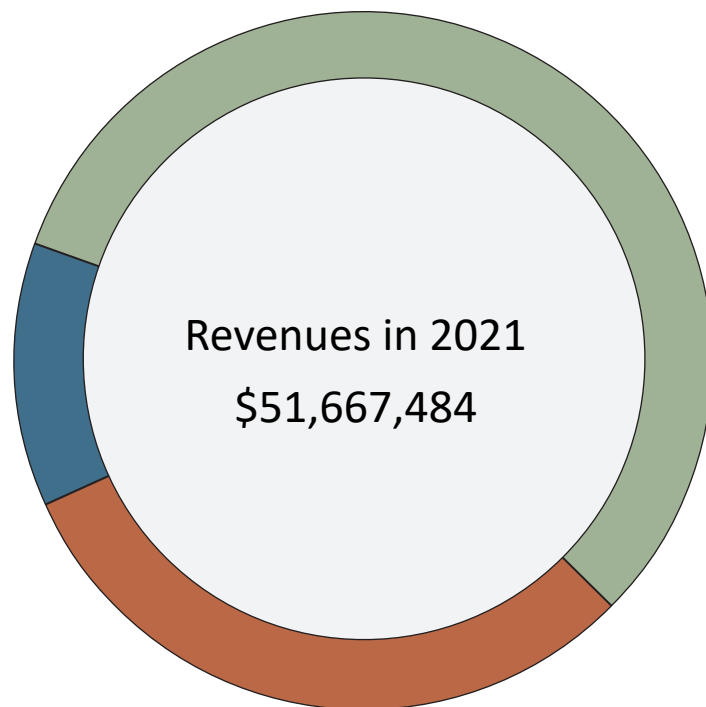

Throughout the pandemic, our senior leadership team has displayed strength and vision, and has pivoted to meet community needs.



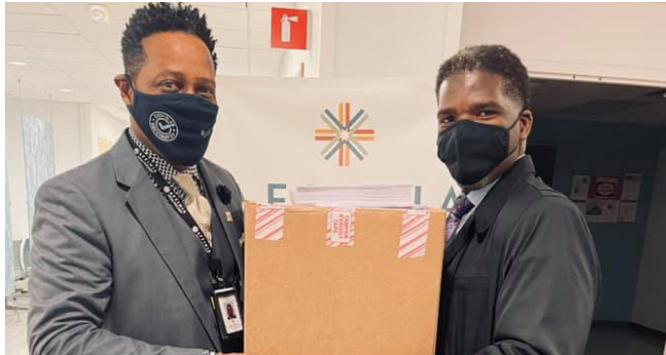
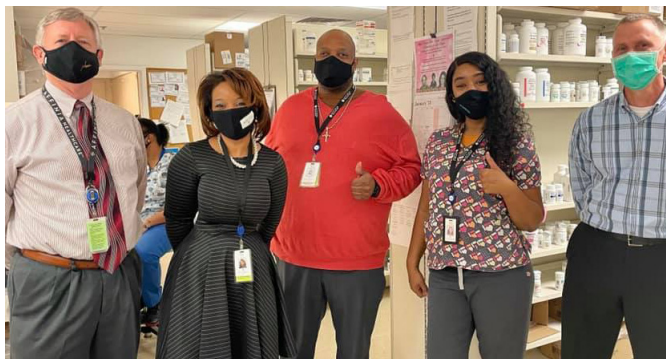

The film features Affinia Healthcare’s exceptional response to the threat of COVID-19, caring for the most vulnerable individuals and under-resourced communities St. Louis region. Yvonne Buhlinger, Executive Vice President, worked with Metrospect Media and oversaw the creation of this impressive documentary. The documentary film viewing became the centerpiece of our fundraising efforts during 2021.

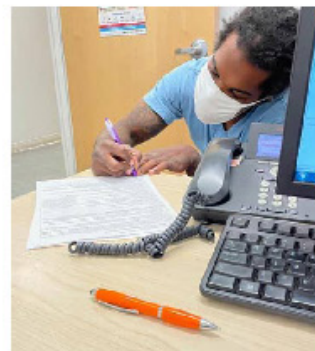
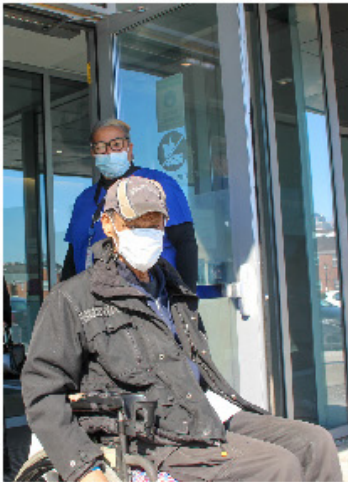

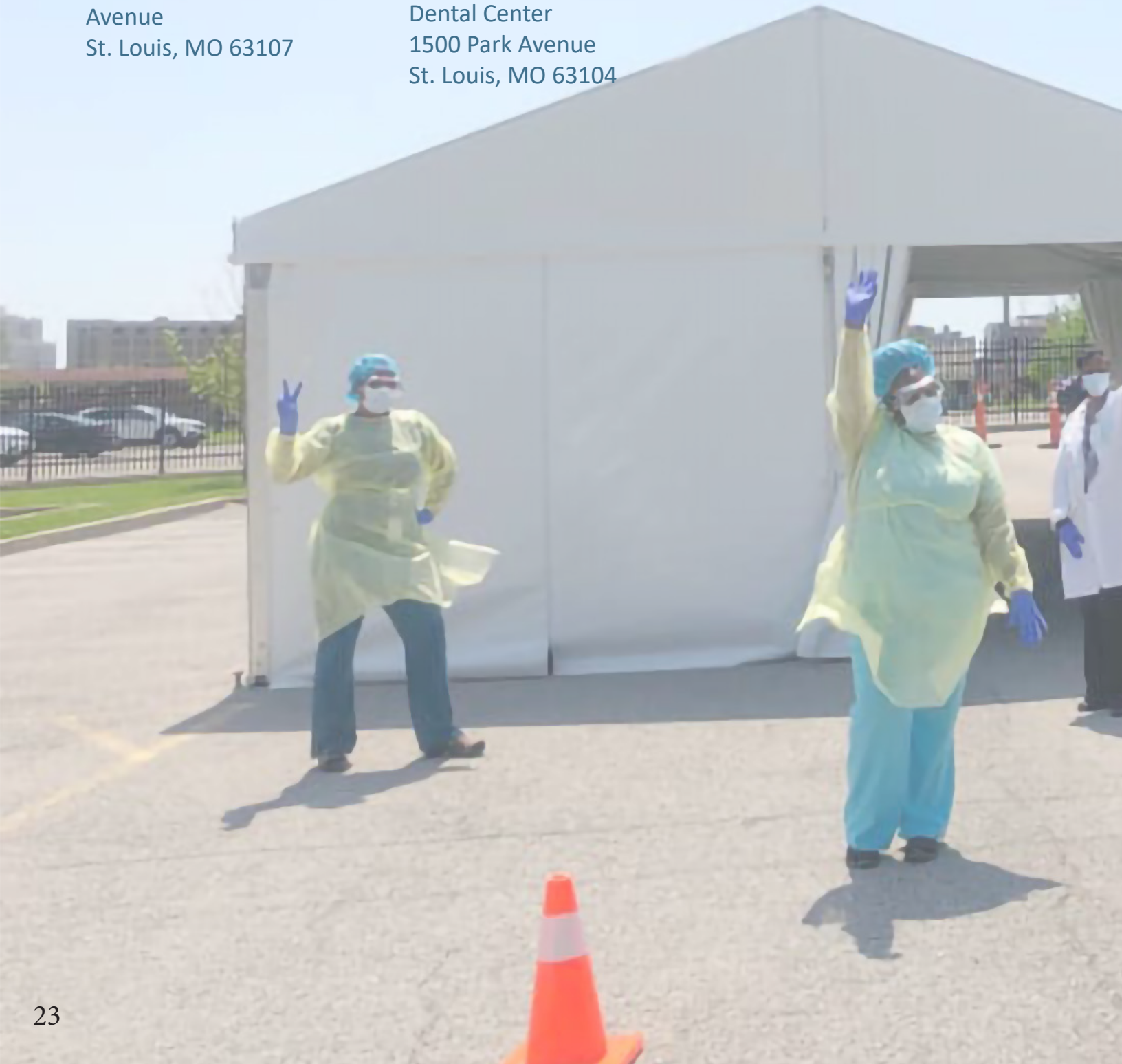
